("Altri") hereby communicates the completion of the private placement by means of non-secure exclusive accelerated bookbuilding exclusively addressed to qualified investors (the "Offering") of 1,866,119 shares representing 1.34% of the share capital and voting rights of Greenvolt – Energias Renováveis, S.A. ("Greenvolt") directly held by Altri (the "Shares").

Banco Santander, S.A. ("Banco Santander") acted as the Sole Global Coordinator of the Offering.

The total amount of the transaction was of 11,196,714 Euro, corresponding to a sale price of \in 6.00 per share of Greenvolt.

Upon completion of this transaction, Altri will no longer hold any participation in Greenvolt's share capital.

The settlement of the Offer will take place on June 2nd, 2023, through the delivery of the Shares versus payment of their price to Altri.
